



# International Student Financial Certificate

All international undergraduate applicants for the 2024-2025 academic year are required to certify that the sum of \$67,214 (includes tuition and fees, living expenses, and health insurance) will be available during the first academic year of study. Your MSOE scholarship will be subtracted from this number.

Please remember you are financially responsible for your entire program of study.

Students holding F-1 visas are not authorized to work off campus during their first academic year. Employment, either part time during the academic year or full time during the summer, should not be considered a means of support while attending MSOE. Under no circumstances are international students permitted to work full time during the academic year.

Married students who plan to bring a spouse and/or children must certify a proportionately larger amount of finances on the basis of at least an additional \$4,500 per year (\$375 per month) for a spouse and \$2,400 (\$200 per month) for each child. F-2 visa holders (dependents of an F-1 visa holder) are not permitted to work under any circumstances.

A copy of this and other financial documentation may need to be provided to the United States Consulate/Embassy officials at the time of visa application.

**PLEASE NOTE:** Milwaukee School of Engineering does not issue Form DS-2019 for obtaining the J-1 (exchange visitor) visa. A Form I-20 (certificate for eligibility for F-1 visa) cannot be issued to you until you have been admitted to MSOE and have submitted original documents demonstrating proof of financial capability.
