Online Counseling Options

Online counseling options exist in which you can communicate with a licensed counselor via messages (like email or live chat), phone or video sessions. Students find this service to be very convenient in that they can send messages to their counselor at any time or schedule sessions at times that work best for them. They also do not have to travel anywhere for appointments.

Insurance companies typically do not cover this service; however, some will reimburse you for a portion of the services. You would need to call your insurance company and ask specifically if they cover online mental health services, mentioning the specific service/site you plan to use.

Most of these services will offer a sliding fee scale based on your income/ financial information, making most options affordable if you want regular contact with a counselor. Fees are typically based on a subscription (such as monthly rates).

Check out the individual websites for more information on their plans and fees. You are also able to download an app for your Apple or Android devices for counseling on the go.
